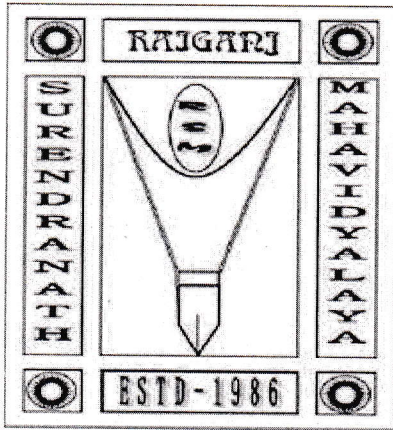

### **TERMS AND EXPIRATION OF THE AGREEMENT:**

It is understood that this agreement will come into effect after being signed by both parties and will be continued for a period of 5 years. After 5 years it will be automatically extended for the same period unless anyone of the parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the parties.

Any additions, changes or deletion to this document must be approved by the representatives of both. All notices shall be given in writing and shall be directed to this representatives.


### **SPECIAL PROVISIONS :**


